In *In re Walgreen Company Stockholder Litigation* (“*In re Walgreen Co.*”), the Seventh Circuit rejected such a settlement, endorsing the standard for approval of disclosure-only settlements articulated by the Delaware Court of Chancery in *In re Trulia, Inc. Shareholder Litigation* (“*In re Trulia*”).

The first of these relates to the Delaware Chancery Court's January 2016 court decision in the In re Trulia Shareholder litigation . In the Trulia case, Chancellor Andre G. Bouchard refused to approve the disclosure-only settlement of a lawsuit a shareholder had filed objecting to the disclosures accompanying Zillow's acquisition of Trulia.
